## To become a qualifying artist:

1. All work shown must be the artist's own creative, original concept, design, and execution, and must be personally exhibited.
2. Prints are allowed.
3. Along with the application, 3 photographs must be submitted representing work to be shown at the Festival. Photos will be returned by mail if not accepted and at the event if the artist has been selected to participate.
4. Qualifying applicants will be accepted on a first-come, first-served basis as checks for the full amount are received.
  5. Two or more applicants may share booth space at no extra charge and must apply together. Each person must send three photos representing the work they will show at the festival.
6. Booth spaces are outdoor 10'x10' areas of hard surfaces. Each space rents for \$50 if received by June 15 or \$60 if received after. Applicants may rent one or more spaces as needed. Electricity is not available and generators are not allowed.
7. Exhibitors are responsible for setting up and attending to their own booths. If you need booth sitters for lunch etc. please indicate that on the application.
8. It is strongly suggested that each artist bring a white pop-up tent or at least an attractive, neat tent.....no tarps, please.
9. Each artist must provide all tables, chairs, and other props needed for displaying his or her work.
10. Artists must be present and have booth open for business during all hours of the 2 day event.
11. No food or drink may be sold by participating artists.
12. The art show is a pet free event. Do not bring pets with you to the show unless you must be accompanied by a personal service animal.
13. On Saturday, judges will select artists for awards.....one prize for outstanding 2 dimensional work and one for outstanding 3 dimensional work. There will also be a people's choice award.
